<u>For the record</u>, I received this notice on July 10, 2023, however, dated July 3, 2023, declaring I had to pay this amount due by August 2, 2023, <u>If I should agree with your assessment</u>. No section of U.S. Tax Law listed. Why? Interestingly, I noticed nowhere in this letter you declare my legal tax status or provide "your" 2021 Form 1040 tax return that you stated I filed. I never filed a 2021 tax return with you or any government agency.

FOR THE RECORD, <u>I DO NOT agree with your tax assessment</u>, proposing changes, &/or "Proposed amount due: \$12,080".

FOR THE RECORD, I respectfully request that I be granted 90 days more time to respond to this legal notice, since I have not even been provided with a 30-day notice.

I request you provided a copy of the "2021 Form 1040 tax return", in your filing system.

For the record, you enclosed a "Taxpayer Bill of Rights" document with this IRS Notice. However, as reported in U. S. Tax Court, on 08/07/2000, Docket Number: 8628-00 in the tax assessment case of Terry & Sheila Hinds, Petitioner v. Commissioner of Internal Revenue, Respondent, we declared our legal taxing status is pursuant to 26 U.S. Code §7701. Definitions

(30) United States person

The term "United States person" means-

(A) a citizen or resident of the United States,

Note: The U.S Tax Court removed us from their jurisdiction.

Terry & Sheila Hinds are NOT Taxpayers as within 26 U.S. Code §7701. Definitions. We have established "United States person" taxing status. Read the law. We get to file or declare our official status, such as we are married and have filed only a joint return with you; last time, over two decades ago. We have not filed a 1040 Tax Forms for over 25 years. Look it up if you do not believe this.

Furthermore, in a Federal lawsuit, I advised all entities within U.S. Government ("Gov't.") when a person believes in, practices, or makes a proper return to the IRS and their path of life, beliefs, and practices it manifests [Worship of Argumentative Wealth, Words & Wants of Materialism] ("Worthship"). We have put the IRS &/or Internal Revenue Service on written legal notice numerous times for the last two decades. I have declared my religious beliefs, *inter alia*, by filing on 02/2016 a federal lawsuit against "UNITED STATES" GOVERNMENT, since no one can tell me or show me the law that established the "IRS" or Internal Revenue Service.
