Dear Terry Hinds:

Thank you for your reply dated Dec. 18, 2023, to our inquiry about changes to items on your tax return.

The Notice CP2000 we sent you was a proposed increase to your tax. The increase is based on information employers, banks, or other payers reported to us under your name and taxpayer identification number. If you believe this information is incorrect, provide a signed statement explaining why.

The information we received does not allow us to revise our proposed changes to your return. We are sending you a Notice of Deficiency under separate cover. The Notice of Deficiency will allow you 90 more days to: provide additional information that will change our proposal, send us your signed consent to the changes on the notice; or petition the United States Tax court.

The law requires we charge interest on unpaid tax from the due date (regardless of extensions) to the date you pay the tax in full. The law doesn't allow us to reduce or eliminate interest based on reasonable cause. Refer to Notice 746, Information About Your Notice, Penalty and Interest, on IRS.gov/forms for more detailed information on our interest charges.

If you agree with our proposed tax increase, but can't pay the amount due, sign and return the "Consent to Tax Increase" at the end of this letter. If you filed a joint return, both you and your spouse must sign the consent.

If you can't pay the full amount you owe, pay as much as you can now to limit penalties and interest and arrange to pay the remaining balance. Visit IRS.gov/PaymentPlan for more information on how to apply for installment agreements and online payments agreements.

Send your signed consent or explanation by June 26, 2024. You can also fax your consent or explanation to 877-477-0583 using either a fax machine or an online fax service. Protect yourself when sending

If we don't hear from you by that date, we'll continue to process the proposed changes to your tax return based on the information in our last notice. If you have a balance due, we'll continue to charge interest and applicable penalties until you pay the balance due in full.


