



To Nathan M. Graves, Clerk of Court:

1). On July 8, 2025, [P/P] filed a germane legal document with your office:

PLAINTIFF/PETITIONER'S NOTICE OF APPEAL & ITS JUDICIAL PROCESS

2). On July 9, 2025, I observed on the *pacers system*, the Docket Sheet record (**Doc #38**) revealed this information:

"NOTICE OF APPEAL as to 36 Order of Dismissal (case - Stipulation of Dismissal) by Plaintiff Terry Lee Hinds. (KJS)"

3). [P/P]'s legal document presented *as a legal right*, described & declared at the bottom:

[P/P]'s NOTICE OF APPEAL - Page 1 of 9

4). The Court's Docket sheet should be a proper record reflecting actions & conducted by The Court & the parties involved in a civil action, however (**Doc #38**) creates a real & *prejudicial impact*; when the *judicial process* presents incorrect or missing documents or information that is erroneous, such as "(case - Stipulation of Dismissal) by Plaintiff":

**What does "dismissed by stipulation" mean?**

*"A stipulation of dismissal is a written agreement by all parties to a lawsuit requesting the court dismiss the case. In other words, all parties agree to dismiss the case."*

5). For the official record [P/P] has no knowledge or understanding of **any "dismissed by stipulation"** with the Order of Dismissal, (Doc #36) declaring only that:

Pursuant to the Memorandum and Order issued herein on this day,  
IT IS HEREBY ORDERED that this case is DISMISSED without prejudice.

6). Furthermore, another *prejudicial impact* with (**Doc # 38**) is the *unlawful control &/or illegal encroachment* of [P/P]'s **protected speech** when "**NOTICE OF APPEAL as to 36 Order of Dismissal**" does not represent [P/P]'s legal intent or words used to protect constitutional & statutory rights in this case, particularly, as (**Doc # 38**) declares in part:

Notice is hereby given that TERRY LEE HINDS, Real Party in Interest as Plaintiff/Petitioner, ("[P/P]") appeal(s) to the United States Court of Appeals for the Eighth Circuit from a final judgment, Order of Dismissal [ECF No. 36], Memorandum and Order [ECF No. 35] or other factual determinations in Congress' intent with equity, remedies or "proceed and give judgment according as the right of the cause and matter in law shall appear unto them" of the district court entered in this action on the 11th day of June 2025.

7). This "**NOTICE OF APPEAL as to 36 Order of Dismissal**" make no reference to the other legal positions presented or mentioned above. Also, the Memorandum and Order

[ECF No. 35] makes no mention of “(case - Stipulation of Dismissal) by Plaintiff Terry Lee Hinds” leaving the [P/P]’s to wonder if other documents were not recorded, or documents or *conduct that harms the judicial process* itself; being entered into this record as **a fraud on the court** by (KJS). Maybe, these are just *misguided non-truths* and why “We have a Justice System for a reason.” Whether advanced by a governmental officer or other, to wit:

Fraud on the court occurs when a party engages in intentional misconduct that undermines the integrity of the judicial process. It requires a showing of deliberate misrepresentation or falsification of material facts intended to deceive the court, and it must have a material impact on the case outcome. Unlike common law fraud, fraud on the court focuses on conduct that harms the judicial process itself, rather than just a party in the case.

8). As a former police officer of 16+ years and attached to D.E.A. with a MEGA group as their intelligence officer, I understand people motivations vs governmental endeavors. This case, as a petition, protest & protected speech has a cause of action, counts, claims and claimed rights owed and the proof of wrong doing by the parties sued. The words & thoughts I live by are not an argument, nor are *religious beliefs* in FAITH in [LAW].

9). Consequently, it been said by Case Management Team Leader, Kelley Shirley:

- 1) You cannot successfully protest without a cause. To have a cause there must be proof of a wrong doing. One eye witness account against the word of a law enforcement officer is not proof. Let's let the professionals do their job.
- 2) We have a Justice System for a reason. The news media is not the Justice System. Every story you hear or read is not a fact. In fact, there are a lot of misguided non-truths in every news media story.

10). Mr. Graves, as Clerk of Court I do not know your authority to set the record straight however, I request proper & corrective actions be taken to resolve this legal matter.


